# 5. VEHICLES ELIGIBLE TO PARTICIPATE

As per articles 1.2 and 6.2.1 and 6.2.2 of the 2025 Bridgestone FIA ecoRally Cup Technical Regulations.

The eligible (admitted) vehicles are those listed in the FIA "Compatible Cars" list, in accordance with Article 2 of the 2025 Bridgestone FIA ecoRally Cup Sporting Regulations.

# 6. GENERAL CONDITIONS

# 6.1 The event will be organised in conformity with:

- the FIA International Sporting Code and its appendices;
- the Sporting and Technical Regulations of the Bridgestone FIA ecoRally Cup;
- the applicable prescriptions stated in the National Sporting Regulations;
- and the present Supplementary Regulations.

The Organising Committee will ensure that the event complies with all the rules and regulations stated above, and that the event has received all the required administrative authorisations.

#### 6.2 Insurance

Icelandic law and regulations governing motorsport mandate that all vehicles participating in a motorsport event must show proof of insurance covering both road and regularity sections.

All Icelandic insurance companies have confirmed that the normal vehicle insurance is valid for regularity events with no further confirmation required.

Foreign registered vehicles **must show** written confirmation from the vehicle's insurer that the insurance is valid, without exception, for both road and regularity sections of the event.

The organiser holds a mandatory third party liability insurance of EUR 2.1 million, in accordance with Icelandic law and regulations pertaining to motorsport in Iceland.

# 7. ITINERARY AND LAYOUT

#### 7.1 General

The event is run over two sections, each section with two legs.

Vehicles will be required to enter Parc Fermé prior to the start of the event to be fully charged. Hydrogen vehicles will be escorted to the hydrogen filling station in Reykjavik to fill up before entering Parc Fermé at the start of each section.

The event is run out of Reykjavik.

# 7.2 Itinerary

# 7.2.1 Section 1, leg 1

A total of four regularities covering a total distance of approximately 164 km of which approximately 134 km are regularities, with the first vehicle starting at 16:00.

# 7.2.2 Section 1, leg 2

A total of two regularities covering a total distance of approximately 134 km of which approximately 79 km are regularities, with the first vehicle starting at 20:10.

Section 1 will thus cover approximately 298 km of which approximately 213 km are regularities.

# 7.2.3 Section 2, leg 3

A total of four regularities covering a total distance of approximately 161 km of which approximately 90 km are regularities, with the first vehicle starting at 7:30.

# 7.2.4 Section 2, leg 4

A total of three regularities covering a total distance of approximately 128 km of which approximately 102 km are regularities, with the first vehicle starting at 12:30.

Section 2 will thus cover approximately 289 km of which approximately 192 km are regularities.

# 7.4 Regrouping

There will be no regrouping during the competition.

# 8. RUNNING OF THE EVENT

# 8.1 Nature of the event

The EcoRally Iceland 2025 is an eco rally that has a combined final classification (regularity + energy performance index), as per Article 3 of the 2025 Bridgestone FIA ecoRally Cup Sporting Regulations.

# 8.2 Start, Finish, Results

#### 8.2.1 Start signal

The start signal for the event will be given at Bæjarháls 1, 110 Reykjavik on the 6-Jun-2025 @ 11:00, when the vehicles will be placed in Parc Fermé and charged prior to the start.

The first vehicle will start 6-Jun-2025 @ 16:00.

Between legs and after the finish, the vehicles will remain in Parc Fermé, which they will enter as soon as they finish the preceding leg. At time controls at the end of a leg, vehicles are allowed to arrive early without incurring a time penalty.

The starting sequence will follow the participation number and the vehicles will be started at one-minute intervals. The starting sequence will not change during the event.

#### 8.2.2 Itinerary

Please refer to Articles 1. and 7.2 in these Supplementary Regulations for information on the itinerary.

#### 8.2.3 FIA Metering Devices

During the Technical Checks, after installing the FIA devices in the cars, the car must be moved a few kilometres (4 km minimum, e.g. to the calibration zone) and carry out some procedures in order to verify that the FIA metering devices are working properly. The cars must then return to Parc Fermé as soon as the test course has been completed.

# 8.3 Roadbook availability

A roadbook will be provided to the crews in printed format at most 30 minutes prior to their respective start time.

The roadbook will be made available in PDF format on the bulletin board when the leg starts.

# 9. DRIVERS' MEETING

The Clerk of the Course will hold a Drivers' Meeting at 14:30 on 6-Jun-2025 at the offices of ON at Bæjarháls 1, 110 Reykjavik (GPS: 64.120220, -21.801254). Please follow signs and marshals' instructions for the room the meeting will be held in.

The presence of both crew members (driver and co-driver) is compulsory. Absence, except in cases of Force Majeure decided by the Stewards of the event, will be penalised by adding 50 Regularity points to the final Regularity Results of the competition of the relevant competitor(s). This penalty cannot be appealed.

# 10. CHARGING (BEV/PHEV)

The organising committee will supply electric power for recharging for BEVs and hydrogen for FCEVs.

- a. Charging and recharging will be done at the start / overnight Parc Fermé location (GPS: 64.127766, -21.887424).
- b. Recharging times are in accordance with Article 7.2.
- c. 230V / 32A / 22kW (dependant on vehicle)
- d. Type of socket: IEC 62196-2



# 11. PERFORMANCE INDEX CALCULATION

The Performance Index will be calculated in accordance with Articles 6.2.1 and 6.2.2 of the 2025 Bridgestone FIA ecoRally Cup Technical Regulations.

# 12. THE FIA MEASURING SYSTEM

The FIA measuring system for the energy performance index will be installed by the scrutineers during scrutineering. This cannot be removed, except if authorised by the FIA technical delegate.

# 13. ENTRY PROCEDURE AND FEES

# 13.1 Entry fee

The entry fee is fixed for each crew, comprising of two people (driver and co-driver, or driver and navigator).

The entry fee with the optional advertising proposed by the Organiser is 500 EUR.

An additional 600 EUR will be added to the entry for those not accepting the advertising proposed by the Organiser.

All bank charges will be borne by the entrant.

# 13.2 Refund of Entry Fee

Entry fees will be refunded in full, if the

- a. entry is not accepted;
- b. event is cancelled.

#### 13.3 Crew documents

A crew comprises of one driver and one co-driver, or one driver and one navigator. Both must have the following documents:

- a. Driving licence according to the entered vehicle (not applicable for the co-drivers / navigators).
- b. An IT LSC licence as defined in Article 19 of Appendix L of the International Sporting Code is required. This licence can be obtained for the event and must be valid for its duration and issued by the ASN of the crew or by the organiser's ASN (with the written permission of the competitor's ASN). It must be handed to the participant at the latest during the administrative checks. It will be subject to the payment of a fee of 60 EUR.
- c. A Competitor licence provided by the parent ASN of the entrant. This licence may be combined with the IT LSC licence defined above, but this must be clearly stated on it.
- d. Vehicle document permitting its free circulation on public roads.
- e. If applicable, the vehicle document required in the Technical Regulations of the Bridgestone FIA ecoRally Cup. This is also commonly known as Certification of Conformity (CoC) for the vehicle.
- f. Fully signed driver's and co-driver's/navigators' declaration and undertaking form (downloadable from the erally is website).
- g. Vehicle's valid insurance certificate in accordance with Icelandic traffic laws and regulations governing motorsport in Iceland.

During the initial scrutineering checks crews must show that the vehicle's insurance certificate is in accordance with the Icelandic traffic code and valid for the event in accordance with Article 6.2.

Foreign vehicles must have a declaration from their insurance company stating that the insurance is fully valid on the competitive sections as well as the road sections, without exception. In addition, this declaration must state the crew's accident and injury insurance is also valid during the competition, both on competitive and road sections.

# 13.4 Entry form

Any person, or legal entity, wishing to participate in the event must submit a completed and signed entry form to the event secretariat, together with all other requested documents, photos, etc. before 30-May-2025 @ 18:00.

Please refer to Appendix 1 in these regulations for the entry form.

#### 13.5 Limit to number of vehicles entered

The maximum number of vehicles entered is limited to a total of 30 vehicles. All entry forms received after the above number has been accepted will be entered on a reserve list. Entries will be taken from the reserve list on a first in first out basis.

# 13.6 Minimum number of vehicles entered

The minimum number of vehicles entered is as per Article 12 of the 2025 Bridgestone FIA EcoRally Sporting Regulations.

# 14. Advertising Promotion and Publicity

# 14.1. Official Supporter


The organisation of the event is supported by ON and other companies whose logos must, as a matter of obligation, be displayed on the competition numbers and on any other promotional material intended to be placed on the vehicle. Optional advertising material as indicated by 14.2.g and 14.2.h, may be proposed by the organisers which will be published in a bulletin.

#### 14.2

The Organiser will provide the participants with the following material and services:

- a. Car identification, 600x200mm (1)
   The race numbers are black on green background 192x148mm
- b. Rally plate, 300x160mm (5)
- c. Bridgestone decals, 100x150mm (3)
- d. Organisers advertising 600x200mm (2)
- e. Roadbook measured in kilometres.
- f. Identification badges for the crew.
- g. Trophies and cups for winners and souvenir awards for all.
- h. Refreshments during administrative checks.
- i. Refreshments at the halfway stops.
- j. Tickets for the Prize Giving Ceremony.
- k. Free charging during the event.

The name and the national flag of the driver and co-driver / navigator (4) are produced by the competitor. For further detail please see Article 11.1 of the 2025 Bridgestone FIA ecoRally Cup Sporting Regulations.



# 15. PROTESTS / APPEALS

The protest fee is 800 EUR.

Protests against the preliminary official results of the event must be lodged, in writing, in accordance with the prescriptions set in the International Sporting Code with the Clerk of the Course within 30 minutes of being posted on the official notice board. Upon the expiration of this time period, the preliminary results become final.

Every protest is eligible to be examined by the Stewards of the event only if it is accompanied by the aforementioned protest fee defined in this article, which is not refundable should the protest fail to be upheld.

For the National Court of Appeal, the fees are 1500 EUR. For the FIA International Court of Appeal, the fees are 3000 EUR. The appeal deposit for an international appeal is 3000 EUR.

All protests and/or appeals must be lodged in accordance with Articles 13 and 15 of the International Sporting Code and, where applicable, with the FIA Judicial and Disciplinary Rules.

# 16. APPLICATION AND INTERPRETATION OF THE REGULATIONS

In case of a dispute over the interpretation of the regulations, the English text will prevail.
